Karen Stefkovich, High Street. Franklin Stepped forward.

Mayor Crowley gave his condolences to Ms. Stefkovich regarding the robbery of her family owned business on Main Street.

Ms. Stefkovich thanked the Borough's detective which she referred to as detective Nevin [Mattessich]. She praised him and the job he did. Ms. Stefkovich explained how Detective Mattessich helped her during the robbery. Ms. Stefkovich commented he [Detective Mattessich] is very intelligent he works none stop, all her emails and phone calls where answered.

Discussion on Group 5 Developer's Agreement

Mr. Ursin commented the Council is familiar with the Group 5 Development proposed Wal-Mart off of Rt 23. Previously the Council has already approved the developers agreement, as a result of the Wal-Mart project being canceled there are some permitting issues. The Developer has asked for some small amendments to the developers agreement. Essentially the small amendments that are in front or you would allow some of the initial and aesthetic work closer to Rt 23 to be performed before what was previously, the Phase One work. Mr. Ursin stated he is recommending this to the Council because the Borough Administrator and Borough Engineer both agree the work that would be performed would make an aesthetic improvement to the property while there is more negotiation to the success of this project. It is important so permits can be issued and we don't lose the site; not just to the developer but the Borough permanently.

Mayor Crowley stated the Council has copies with the changes in red.

Mr. Snyder asked if this had anything to do with the ingress and egress of the development behind [the property]

Mr. Ursin commented no.

There was a brief discussion on the changes to the developers agreement.

Mr. Snyder asked if the future development of that area behind would not affect the way DOT approved it prior to the possible changing of this.

Mr. Ursin commented right, keep in mind, nothing that you are approving in this developers agreement would have any effect on what that end project would be. In fact, nothing you are approving tonight changes what the Planning Board has already put in place as far as the phasing of the work, access to Rte 23 all that is set forth in the Planning Board Resolution. The Council would not have the power to change that even if you wanted to; the developers agreement is the document for construction to be completed based upon the Planning Board Resolution. Mr. Ursin stated the changes to the developers agreement doesn't have any effect what so ever on access, highway, circulation patterns, nothing like that. Mr. Ursin asked Mr. Kilduff if he agreed with that.

Discussion on Capital Improvements and Financing

Mr. Kilduff explained the street and road improvement plan that was in front of the Council. He explained the schedule, the cost to repave the roads and the financing part of the road improvements. Mr. Kilduff explained milling and repaving versus stone and the life expectancy of both.

Monica Miebach, CFO was also present to explain the financing for the capital projects.

The Council had a very lengthy discussion on road improvements, DOT grants, buying equipment and having a paving crew, taking on debt for this project and paying for a project each year.

Mrs. Miebach explained some debt is paid in full this year. It is the perfect opportunity for the Borough to look for capital improvements and how to finance them. The smartest finance advice is to always keep your debt ratio the same. Mrs. Miebach stated we have \$175,000 this year to pay for the Borough's first year roll. Mrs. Miebach explained the Borough's financial situation.

There was a discussion on lowering the Borough's debt ratio, bonds, BANS, one year note, using the \$175,000 for one project without taking on debt and other small projects on the list. Small projects include a security system for the Municipal Building cost is approximately \$7,000 for 7 cameras a basic system, new furnace for the fire department, police department and senior building and salt shed down at DPW.

Mrs. Miebach commented she has a quote for the Fire House conversion, it is just under \$20,000. Mrs. Miebach explained she will be working with Brian Vandenbroek, calling vendors to bring them in for quotes for furnaces and to try and go with a two year contract. Then see which furnace would really need to be done first.

Capital Improvement Projects:

1. Roads
2. Fire Department conversion
3. Security for the Municipal Building
4. Side and front lock enclosures for the salt shed.

Mrs. Miebach explained when the Council decides what they would like done, she need to contact bond council. They prepare the ordinance for the Borough which has to be done is a special way.

Mrs. Miebach explained this will be a new note, for new debt and explained the procedure.

The Council continued to discuss capital improvements.

Mr. Zschack stated to take the \$175,000 and use it for the items we discussed and not have to bond.

Mr. Giordano commented we had talked about capital improvements done at the pond. Mr. Giordano stated he is not prepared to make a decision tonight. He has spent a lot of time down at the pond, we need a security system down there because things are often destroyed. Mr. Giordano stated to put this off for one month and have the adhoc committee from recreation meet with the Mayor and the finance committee and see if there are things that can be done down there [at the pond]. Mr. Giordano commented we [recreation] have a lot of money in a fund that if we were to get a small portion in this banding, we could take care of a lot of things we want to take care of in Recreation, in addition to beautifying the Borough.

Mr. Giordano commented the \$175,000 could be used for salt shed, security here and at the pond.

Mr. Kilduff stated it doesn't begin to approach what we are talking about with the road project.

The discussion continued with capital improvements projects, dollar amount to spend for the projects, the rates being lower, concern of having additional debt payments, the cost of bond council, work will probably be done spring of 2014 and the Council members went back and forth as to the dollar amount.

Mr. Giordano and Mr. Zschack gave concerns regarding going out for additional debt. Mr. Zschack commented he also realizes the need to pave the roads.

Mayor Crowley commented the priority should be the roads, the longer the Borough puts it off, the worse they are going to be.

*Mr. Snyder made a motion spend \$275,000 for capital improvements, the roads etc.

Mr. Limon asked if it included the security system for Borough Hall.

Mr. Ursin stated you are setting the dollar amount by this motion you are not deciding on the projects with this motion.

Discussion on changes to Chapter 161 Land Development

Mayor Crowley commented his feeling is if someone has enough money to have a recreation vehicle, they should store it someplace. It should be shielded on the side or in back of the house; as far as emergency vehicles, one person approached the Council because he had a wrecker he used for emergency and all of a sudden we are changing an ordinance. He doesn't consider a wrecker an emergency vehicle even if it is on call or not.

Mr. Zschack stated the recommendations weren't made because of complaints. The complaints made us aware of the ordinance, we [the committee] read the ordinance and felt things didn't make sense. It had nothing to do because someone didn't like this. The committee picked out things in the ordinance that didn't make sense. People are always not going to like what we do, people are always going to complain, that wasn't part of the factor in coming up with these suggestions.

Mr. Kilduff commented he provided some thoughts. On the commercial vehicles in a residential zone, the new ordinance proposes to increase the weight of a commercial truck that could be park at a residence from 7 to 10 thousand pounds. Mr. Kilduff stated when he did some checking, that's a number he is seeing in other town ordinances.

Mr. Zschack stated that is why we [the committee] made that recommendation.

Mr. Kilduff commented that makes sense. Mr. Kilduff stated it also says this provision shall not be deemed to limit the use of the commercial vehicle stored in a garage on the premises. What he got from that you can have a 10 thousand pound vehicle in a residential zone; you can have any commercial without restriction that you can fit in a garage. Mr. Kilduff suggested to the Council that you would be getting into some difficult areas when a truck that size comes motoring down the street. Mr. Kilduff commented when reading this it doesn't imply to vehicles in connection with farming operations and then it references four other types of vans. Mr. Kilduff continued to explain the weight of vans. He provided the Council with a memo and pictures which he explained. Mr. Kilduff commented on the need to define what "on call" means.

Mr. Kilduff stated what he noticed in the proposed ordinance is that recreation vehicles would no longer have to be screened from view. The setback requirements have changes so that recreation vehicles would now be allowed in a front yard where the house was set back sufficiently to meet this new requirement for a 25 foot setback. Mr. Kilduff commented generally ordinances he has seen for recreational vehicles you tend to try and get them to be parked on the side yard or the back yard, not in the front yard. Mr. Kilduff suggested the committee to consider that; in an effort to make it a little easier for some of our residents, you might have a situation where you go down the street and have giant boats parked in the front [yard]. Mr. Kilduff stated it becomes a question of what should we as property owners be allowed and what becomes visually offensive to neighbors. He cautioned the committee about allowing recreation vehicles in front yards.

Mr. Zschack stated we will take a look at these suggestions as a committee, the rest of the Council needs to look at this too, drive around and look around [the Borough]

Mr. Giordano stated he thinks we can change C to be in the side yard but if someone has a recreation vehicle they want to park on the side of their house, until someone pays their taxes it is still their property. Mr. Giordano commented this is intruding on someone's personal space, if he pays his taxes and his mortgage then he considers his property to be his. Get along with your neighbor, if your neighbor doesn't like the fact you have a boat, talk to your neighbor about it.

Mr. Babcock referred to pictures Mrs. Gardell had at the committee meeting. Mr. Babcock stated he didn't see anything wrong with those pictures.

Mr. Zschack stated the committee will look at this and take Mr. Kilduff's comments into consideration. Mr. Zschack commented that's what the committee was looking for comments back from the Council and Administration.

Mr. Snyder stated at the last meeting he asked if we would be able to do something with the ordinance beyond what you [the committee] has done here, to look at the people who have registered and insured [vehicles] on a residential lot and do not move those vehicles; they sit continuously year round and never move. Mr. Snyder commented if it was him looking at a neighbor with 10 cars in their front and back yard, he would want to have something done. Mr. Snyder stated that is what we need to do because there are other vehicles now that are on private property or
