Mr. Kilduff asked if voting was finished. Mrs. Murphy agreed. Mr. Kell said four in (favor) and one abstained.

Mr. Kilduff said there were seven and couldn't hear. Mr. Kell said four voted and one abstained. Mr. Kilduff said that's five votes and asked what the other two are. Mrs. Murphy said, "We didn't." Mr. Kell said we didn't vote because we didn't participate in the Walgreen's application. Mr. Kilduff inquired, there were three abstentions. Mr. Kell said, "I didn't even put us up for a vote." Mr. Martinez said he abstained because he wasn't here the whole year.

Mr. Kilduff said this is a report that's generated through the Zoning Board and most of this report revolves around two cases. There's a question for the attorney as to voting eligibility on a report for the whole year when some of the members obviously did not sit on all the application.

Mr. Kell suggested holding off and waiting till next month for (Mr. Kilduff) to talk to Mr. Brady. Mr. Kilduff said you could do that and they've already voted. Mr. Correal said there's five counted votes; being sufficient. Mr. Kilduff said, "No it's a question of the eligibility." A person voted on a report and they weren't involved in the application.

Mr. Correal said they didn't vote they abstained; we have five standing votes; and if we pass it. Mrs. Murphy said you don't have five. Mr. Kilduff said we have three abstentions. Mrs. Murphy said you don't have five, you only have four. Mr. Kilduff said we can check with the attorney. I couldn't hear how the vote went and you've already voted. Mr. Kell said if there's a problem they can bring it back next month. Mr. Kilduff agreed.

Mrs. Murphy said she just didn't want to vote on something she doesn't know. Mr. Kilduff asked if she abstained and Mrs. Murphy agreed. She said Mr. Kell, herself and Mr. Martinez.
