ORDINANCE # 04-2015**

EMERGENCY CONTRACT FOR WATER STORAGE TANK

AN ORDINANCE APPROPRIATING A NOT TO EXCEED SUM OF \$85,000.00 FROM RESERVE FOR CAPITAL OUTLAY, RESERVE FOR WATER/SEWER EQUIPMENT AND THE RESERVE FOR CAPITAL IMPROVEMENTS TO WATER DISTRIBUTION BY THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY.

BE IT ORDAINED AND ENACTED by the Mayor and Council of the Borough of Franklin, County of Sussex, New Jersey, as follows:

SECTION 1: The sum not to exceed \$85,000. to be utilized out of the Reserve for Capital Outlay, Reserve for Water/Sewer Equipment and the Reserve for Capital Improvements to Water Distribution is hereby appropriated for the following purpose:

For the Fixing of the Leaking Intake and Feed Piping of Franklin Meadows Water Storage Spheroid 300,000 gallon tank.


SECTION 2: In connection with the amount authorized in Section 1 hereof, the Borough makes the following determination:


- (a) The purpose described in Section 1 hereof is not a Current Expense and is an improvement, which the Borough of Franklin may lawfully make as a Water/Sewer Capital Improvement.
- (b) The period of usefulness of the purpose described in section 1 hereof is not in the limitations of the said Local Bond Law and according to the aggregate reasonable life thereof is five (5) years.


SECTION 3: All ordinances or parts of ordinances, which are inconsistent with the terms of this ordinance, be and the same is hereby-repealed to the extent of their inconsistency.

SECTION 4: This ordinance becomes effective immediately upon final passage, approval, and publication as provided by law.




