EMERGENCY CONTRACT FOR WATER STORAGE TANK

**[This Ordinance amends Ordinance #4-2015 correcting the amount authorized]
AN ORDINANCE APPROPRIATING A NOT TO EXCEED SUM OF
\$86,608.57 FROM RESERVE FOR CAPITAL OUTLAY, RESERVE FOR
WATER/SEWER EQUIPMENT AND THE RESERVE FOR CAPITAL
IMPROVEMENTS TO WATER DISTRIBUTION BY THE BOROUGH OF
FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY.**

BE IT ORDAINED AND ENACTED by the Mayor and Council of the Borough of Franklin, County of Sussex, New Jersey, as follows:

SECTION 1: The sum not to exceed \$86,608.57 to be utilized out of the Reserve for Capital Outlay, Reserve for Water/Sewer Equipment and the Reserve for Capital Improvements to Water Distribution is hereby appropriated for the following purpose:

For the Fixing of the Leaking Intake and Feed Piping of Franklin Meadows Water Storage Spheroid 300,000 gallon tank.


SECTION 2: In connection with the amount authorized in Section 1 hereof, the Borough makes the following determination:


- (a) The purpose described in Section 1 hereof is not a Current Expense and is an improvement, which the Borough of Franklin may lawfully make as a Water/Sewer Capital Improvement.
- (b) The period of usefulness of the purpose described in section 1 hereof is not in the limitations of the said Local Bond Law and according to the aggregate reasonable life thereof is five (5) years.

SECTION 3: All ordinances or parts of ordinances, which are inconsistent with the terms of this ordinance, be and the same is hereby-repealed to the extent of their inconsistency.


SECTION 4: This ordinance becomes effective immediately upon final passage, approval, and publication as provided by law.


