**ORDINANCE NO. 12 - 2015**

**AN ORDINANCE OF THE BOROUGH OF FRANKLIN,  
COUNTY OF SUSSEX, AND STATE OF NEW JERSEY  
AMENDING CHAPTERS 92 AND 119 OF THE BOROUGH  
CODE ENTITLED "BOATS AND BOATING" AND "FEES"**

**BE IT ORDAINED** by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey that Chapters 92 and 119 of the Code of the Borough of Franklin entitled "Boats and Boating" and "Fees" respectively are hereby amended as follows:

**SECTION I.**

Chapter 92 of the Code of the Borough of Franklin entitled "Boats and Boating" is hereby amended by deleting Section 92-5 entitled "Permit required; term; issuance" in its entirety and replacing same as follows:

**§92-5. Permit required; term; issuance**

Prior to the operation of a non-motorized watercraft on Franklin pond in Franklin Borough, the operator must obtain a boating permit from the Borough of Franklin. Said boating permit shall be valid for one year beginning January 1 and ending December 31 each year. This permit shall be valid only when issued to and held by a resident or non-resident of the Borough of Franklin who is 18 years of age or older. This permit shall be valid for the operation and maintenance of a non-motorized watercraft for the use of the holder thereof as well as his guests and the members of his family; provided, however, that the operation of said non-motorized watercraft shall be at all times under the supervision of the holder of this permit. Each permit shall be valid for one boat only. All occupants of any boat operating under a permit granted under this section shall wear life vests at all times.

**SECTION II.**

Chapter 119-2(A) of the Code of the Borough of Franklin entitled "Fees" is hereby amended to delete the fees established for "Fishing permit" in their entirety and replace same as follows:

**119-2. Miscellaneous fees; public records; and redemption calculations**

**SECTION III.**

Chapter 119-4 of the Code of the Borough of Franklin entitled "General fees" is hereby amended to delete the fees established for "Ch. 92, Boats and Boating" in their entirety and replace same as follows:

**119-4. General fees.**

**SECTION IV.**

All other provisions of Chapters 92 and 119 of the Code of the Borough of Franklin shall remain unchanged.

**SECTION V.**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

**SECTION VI.**

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.


**SECTION VII.**






