## BOROUGH OF FRANKLIN ORDINANCE NO. 01-2017

AN ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY AMENDING ARTICLE II, CHAPTER 5 ENTITLED "ADMINISTRATION OF GOVERNMENT" OF THE CODE OF THE BOROUGH OF FRANKLIN, TO RESCIND AND REPLACE SUBSECTIONS 5.4, 5.5 AND 5.7 – RULES OF COUNCIL, ORDINANCES AND RESOLUTIONS, AND POWERS AND DUTIES OF THE MAYOR

**BE IT ORDAINED** by the Council of the Borough of Franklin, in the County of Sussex and State of New Jersey that existing Article II, Chapter 5, Subsection 5.4, 5.5 and 5.7 of the Code of the Borough of Franklin entitled "Rules of Council," Ordinances and Resolutions," and "Powers and Duties of the Mayor" are each rescinded and replaced as follows:

#### Section 1 -

Subsection 5.7 "Powers and Duties of the Mayor" is hereby repealed in its entirety and replaced with the following:

- § 5.7. "Powers and Duties of the Mayor"
- A. The Powers and Duties of the Mayor shall be those be and are those as established at <u>N.J.S.A.</u> 40A:60-5.

#### Section 2 -

Subsection 5.4 "Rules of Council" and Subsection 5.5 Ordinances and Resolutions" are each hereby repealed in their entirety and replaced with the following:

- § 5.4. "Powers and Duties of the Council"
- A. The Powers and Duties of the Council shall be those be and are those as established at N.J.S.A. 40A:60-6.
  - B. Intentionally left blank.

#### Section 3 - When Effective

This ordinance shall take effect upon passage and publication as required by law.
