# ORDINANCE RENAMING "HOSPITAL ROAD" AS "SERGEANT DENNIS F. PREMOCK ROAD" IN THE BOROUGH OF FRANKLIN IN HONOR OF THE LIFE AND LEGACY OF SGT DENNIS F. PREMOCK

WHEREAS, Dennis F. Premock, a son of Franklin Borough, New Jersey, in the County of Sussex, served his nation honorably as a Sergeant in the United States Army; and

WHEREAS, in 1968, Dennis F. Premock fought valiantly and honorably in the Vietnam War and was killed in action during his military services; and

WHEREAS, on May 23, 2017, the Franklin Borough Mayor and Council resolved to honor the life and legacy of Sergeant Dennis F. Premock by renaming "Hospital Road" as "Sergeant Dennis F. Premock Road" to enshrine and memorialize the memory of this fallen comrade and hero within the Borough's storied history, and directed the Borough clerk, administrator, and legal counsel to undertake all necessary measures to perfect same; and,

NOW, THEREFORE, BE IT ORDAINED, that the Borough of Franklin of the County of Sussex does hereby rename and dedicate that certain public roadway heretofore known as and named "Hospital Road," upon full adoption and certification of this Ordinance in accordance with law, going forward, to be known as and named "Sergeant Dennis F. Premock Road"; and

BE IT FURTHER RESOLVED, by the Governing Body of the Borough of Franklin, that the Mayor, clerk, administrator and/or legal counsel, as well as all other persons who may need to be, are hereby authorized and empowered to take all appropriate and necessary actions to perfect this renaming and dedication including without limitation, redrawing of maps and labels and notification of all federal, state, local and other entities, and to seek all necessary approvals or other affirmations and endorsements needed to carry out to intent and direction of the Governing Body of the Borough of Franklin; and

**BE IT FURTHER RESOLVED**, certified copies of this resolution shall be forwarded to Catherine M. Williams, Clerk of the Board of Chosen Freeholders of the County of Sussex, and any other public official who shall have need for notice of same.

BE IT FURTHER RESOLVED, this Ordinance shall take immediately upon adoption on second reading in accordance with law.
