ORDINANCE 11-2017**

**ORDINANCE RENAMING "INDEPENDENCE LANE" AS "DINA'S WAY"
IN THE BOROUGH OF FRANKLIN IN HONOR OF
THE LIFE AND LEGACY OF DINA ARRIGO WYCKOFF**

WHEREAS, on or about May 5, 2017, Sharon Nann, CMCA, AMS, of Taylor Management, Inc., submitted correspondence to the Franklin Borough Governing Body stating,

By a unanimous vote of the Franklin Meadows Community Association, Inc. Board of Trustees on Monday, May 1, 2017, FMCA respectfully recommends to the Franklin Borough Council that Independence Way [sic] be renamed as Dina Drive.

Dina Arrigo Wyckoff was a former long term resident and grew up in Franklin Meadows. Her parents John and Donna still reside in Franklin Meadows. Dina contributed immeasurably to the community and the Borough during her life, just as her parents did and continue to do. The Board feels this would be a fitting memorialization based on the unique and profound impact Dina had.

WHEREAS, on May 9, 2017, the Franklin Borough Mayor and Council considered the application and found the proposed public road renaming a fitting tribute to this daughter of Franklin Borough, Dina Arrigo Wyckoff, whose life touched so many and who contributed immeasurably to her community and this Borough; and,

WHEREAS, on May 9, 2017, the Franklin Borough Mayor and Council resolved to formally rename Independence Lane as Dina's Way in furtherance of its findings and tribute to Dina Arrigo Wyckoff, and directed the Borough clerk, administrator, and legal counsel to undertake all necessary measures to perfect same; and,

NOW, THEREFORE, BE IT ORDAINED, that the Borough of Franklin of the County of Sussex does hereby rename and dedicate that certain public roadway heretofore known as and named "Independence Lane," upon full adoption and certification of this Ordinance in accordance with law, going forward, to be known as and named "Dina's Way"; and

BE IT FURTHER RESOLVED, by the Governing Body of the Borough of Franklin, that the Mayor, clerk, administrator and/or legal counsel, as well as all other persons who may need to be, are hereby authorized and empowered to take all appropriate and necessary actions to perfect this renaming and dedication including without limitation, redrawing of maps and labels and notification of all federal, state, local and other entities, and to seek all necessary approvals or other affirmations and endorsements needed to carry out to intent and direction of the Governing Body of the Borough of Franklin; and

BE IT FURTHER RESOLVED, certified copies of this resolution shall be forwarded to Catherine Williams, Clerk of the Board of Chosen Freeholders of the County of Sussex, and any other public official who shall have need for notice of same.

BE IT FURTHER RESOLVED, this Ordinance shall take immediately upon adoption on second reading in accordance with law.
