**AN ORDINANCE AMENDING CHAPTER 259 "PARKING," Code of the  
Borough of Franklin § 259-5**

**WHEREAS**, the Franklin Borough Mayor and Council finds and declares the promotion of vehicular and pedestrian safety on the Borough's streets and roads is of paramount concern; and

**WHEREAS**, Franklin Borough desires to amend certain specific parking requirements under the Code of the Borough of Franklin §259-5, as more specifically stated below;

**NOW, THEREFORE, BE IT ORDAINED** by the Franklin Borough Mayor and Council amends the Borough Code as follows with **bolded & underlined text** representing new text to be added as part of this amendment, and ~~strikethrough-text~~ representing deleted text as follows:

**Chapter 259 "Parking"**

**Section §259-5**

...

**E.** Parking time limited on certain streets. No person shall park a vehicle for longer than the time limit between the hours listed on any day (except Sundays and public holidays) upon any of the streets or parts of streets described.

<b>Name of Street</b>	<b>Sides</b>	<b>Time Limit (hours)</b>	<b>Location</b>
Main Street	North	1/2	From the intersection of Main Street and Junction Street, 220 feet in an easterly direction
Main Street	North	2	From a point beginning 220 feet in an easterly direction from the intersection of Main Street and Junction Street, extending to Hudson Street
Main Street	North	2	From a point beginning 235 feet in an easterly direction from the intersection of Main Street and Wyker Road, extending to Junction Street
<b><u>Main Street</u></b>	<b><u>North</u></b>	<b><u>2</u></b>	<b><u>From the intersection of Main Street and Junction Street extending in an easterly direction to the intersection of Main Street and Parker Street</u></b>




