# AN ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY AMENDING CHAPTER 119 OF THE BOROUGH CODE ENTITLED "FEES"

**BE IT ORDAINED** by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey that 119 of the Code of the Borough of Franklin entitled "Fees" is hereby amended as follows:

#### **SECTION I.**

Chapter 119-2A of the Code of the Borough of Franklin entitled "Fees" is hereby amended to delete the fees established for "Beach Access" in its entirety and replace same as follows:

# Franklin Pond Beach - Memberships/Passes

**Annual Passes** 

Family Resident Pass (up to 5 people in the same household) - \$50

(If family is larger than 5, additional badges may be purchased at a cost of \$20)

Single Resident Pass - \$10

Senior Citizen Resident Pass (age 65 & up) - \$5

Children Age 3 and under – No Charge

Veterans (with proper identification provided) - No Charge

Daily Passes

Daily Resident Wristband - \$5

Daily Guest Wristband - \$10 (Must be accompanied by a Franklin resident)

Daily Senior Resident Wristband \$3.00

#### **SECTION II.**

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

#### **SECTION III.**

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

#### **SECTION IV.**

This Ordinance shall take effect immediately upon final publication as provided by law.
