## **ORDINANCE** #09-2019

ORDINANCE PROVIDING FOR VARIOUS IMPROVEMENTS OR PURPOSES TO BE UNDERTAKEN BY THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY, AND APPROPRIATING \$45,300 THEREFOR FROM VARIOUS FUNDS OF THE BOROUGH.

# BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:

Section 1. The improvement described in Section 2 of this ordinance are hereby authorized as general improvements to be made or acquired by The Borough of Franklin, New Jersey, and there is hereby appropriated therefor the sum of \$45,300, to the extent of \$16,100, from moneys available in the Reserve for Municipal Property of the Borough, to the extent of \$4,200, from moneys available in the Reserve for Streets and Roads of the Borough, and, to the extent of \$25,000, from moneys available in the Capital Improvement Fund of the Borough.

Section 2. The improvements hereby authorized and the purposes for the financing of which the appropriation is made as provided in Section 1 of this ordinance are as follows: the acquisition, by purchase, of new and additional equipment for use by Police Department of the Borough, including a storage unit, modems and a traffic box; the acquisition and installation of a new phone system at the municipal building in the Borough; and accreditation for the Police Department of the Borough, together with for all the aforesaid, all appurtenances, attachments and equipment necessary therefor or incidental thereto, all as shown on and in accordance with the specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the

amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final passage as provided by law.
