#### ORDINANCE #10-2019

ORDINANCE PROVIDING FOR THE ACQUISITION OF NEW EQUIPMENT BY THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY, AND APPROPRIATING \$48,500 THEREFOR FROM THE WATER/SEWER CAPITAL IMPROVEMENT FUND OF THE BOROUGH.

# BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF FRANKLIN, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:

Section 1. The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by The Borough of Franklin, New Jersey, and there is hereby appropriated therefor the sum of \$48,500 from moneys available in the Water/Sewer Capital Improvement Fund of the Borough.

Section 2. The improvement hereby authorized and the purpose for which the appropriation is made as provided in Section 1 of this ordinance is the acquisition, by purchase, of new and additional equipment for use by Water/Sewer Utility of the Borough, including one (1) pickup truck with plow and one (1) mower, together with all appurtances, attachments and equipment necessary therefor or incidental thereto, all as shown on and in accordance with the specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

Section 3. The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final passage

as provided by law.
