ORDINANCE No. 16-2019

**AN ORDINANCE OF THE BOROUGH OF FRANKLIN,
COUNTY OF SUSSEX, AND STATE OF NEW JERSEY
AMENDING SECTION 259-13, TURN RESTRICTIONS**

BE IT ORDAINED by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey that the Franklin Borough Code is amended as follows:

SECTION I. Section 259-13 of the Code is hereby replaced as follows:

§ 259-7. Turn restrictions.

No person shall make a turn at the location listed and in the manner described.
No left turn onto Walsh Road from Route 23 North.
No left turn onto North Rutherford Ave. from Route 23 North.

SECTION II

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.


SECTION III

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV


This Ordinance shall take effect immediately upon final publication as provided by law.


