ORDINANCE No. 07-2019

AN ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, AND STATE OF NEW JERSEY AMENDING PORTIONS OF CHAPTER 10

BE IT ORDAINED by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey that Chapter 10 of the Franklin Borough Code is amended as follows:

SECTION I

The following sections are deleted from Chapter 10 and reserved for future use:

- A. Article III, Industrial Commission, §10-11 to §10-18;
- B. Article VIII, Buildings and Grounds Committee, §10-34;
- C. Article IX, Redevelopment Agency, §10-44 to §10-46.

SECTION II

The following chapters are deleted and reserved for future use:

- A. Chapter 19, Cooperative Pricing;
- B. Chapter 18, Contracts;
- C. Chapter 101, Building Numbering;
- D. Chapter 132, Funeral Expenses;
- E. Chapter 165, Licenses and Permits;
- F. Chapter 217, Shooting Galleries, Bowling Alleys, and Billiard Saloons;
- G. Chapter 266, Vending Machine and Coin-Operated Amusement Devices.

SECTION III

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION IV

If any article, section, subsection, paragraph, phrase or sentence is, for any reason, held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION V

This Ordinance shall take effect immediately upon final publication as provided by law.


