A CAPITAL ORDINANCE OF THE BOROUGH OF FRANKLIN, COUNTY OF SUSSEX, STATE OF NEW JERSEY TO AUTHORIZE THE PURCHASE OF EQUIPMENT FOR THE FRANKLIN BOROUGH FIRE DEPARTMENT FROM THE CAPITAL IMPROVEMENT FUND IN THE AMOUNT OF \$13,500

BE IT ORDAINED by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey as follows:

Section 1. Franklin Borough Fire Department has a need for six self-contained breathing apparatus ("SCBA") and one set of turn out gear for emergency responses; and,

Section 2. The Franklin Borough Fire Department has requested that Franklin Borough purchase the essential equipment on behalf of the Fire Department volunteers and has provided a quote for the purchase utilizing New Jersey State Contracts 17Fleet 00819 and 17Fleet00805 and will be expended from the capital improvement fund and shall not exceed \$13,500; and,

Section 3. The Borough hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 4. This Ordinance shall take effect immediately upon adoption in accordance with the laws of the State of New Jersey.
