Committee agreed the fee was waived and those events were good for the library to participate in.

Mrs. Formica stated she didn't thing they charged a vendor fee for National Night Out.

Mrs. Nahrwold confirmed that was correct, no sale vendors are able to participate in National Night Out.

Mrs. Formica stated they normally waive the fee for non-profit.

Recreation Secretary, Suzann Brush, stated someone from Convention of States requested to be a vendor.

Some committee members asked if we allow political vendors.

Mrs. Carnes stated yes.

Committee looked at the associated website and discussed weather this vendor would be a good fit for any of the town events.

Mrs. Carnes stated they would have to pay a normal vendor fee.

Mrs. Sanchez stated as long as we clarify there is no bull horns and shouting and speakers, it would be ok for them to participate.

Mrs. Carnes stated it would just be Franklin Night.

Mrs. Formica stated if they just have a booth and people go to them it should be ok.
