RESOLUTION OF THE BOROUGH OF FRANKLIN AUTHORIZING THE PURCHASE OF A 2026 FORD F-350 REGULAR CAB 4X4 FROM A MCCPC CONTRACT VENDOR

WHEREAS the Borough of Franklin may, by resolution, and without advertising for bids or obtaining quotations, purchase any goods or services as per N.J.S.A. 40A:11-11, under the MCCPC-Contract #15-C, Item #12; and

WHEREAS the Public Works Department needs, on a timely basis, to purchase goods and services utilizing the MCCPC-Contract #15-C, Item #12, duly authorized under law to extend contract pricing to local units, per N.J.A.C. 5:34-7 et al. Seq.; and

WHEREAS the Borough intends to enter into a contract for procurement of a 2026 Ford F-350 Regular Cab 4x4 Pickup from Ciocca Ford, an authorized vendor under MCCPC-Contract #15-C, Item #12; and

WHEREAS, the Chief Financial Officer has certified that funds in the amount not to exceed \$69,668.00 are available in the Capital Budget.
