The salaries and wages fixed by this Ordinance shall be effective January 1, 2022. Said salaries and wages shall remain in effect until this Ordinance is amended or repealed.

**SECTION 3.**

All Borough benefits shall be provided in accordance with contractual obligations and in accordance with existing Borough Ordinances and the Personnel Manual governing municipal employee benefits.

**SECTION 4.**

Nothing in this Ordinance shall be construed as making mandatory the payment of annual salary increments to any officer or employee of the Borough of Franklin. Salary or wage increases shall be contingent upon the availability of funds.

**SECTION 5.**

The adoption of this Ordinance shall not operate to either increase or decrease the present pay of any officer or employee of the Borough of Franklin, and the salaries or compensation under the existing Ordinance shall remain in effect until any additional increments are approved by the Borough Council under this Ordinance. Specific salaries or wages established by the Borough Council may be made retroactive to January 1<sup>st</sup> of the year in which the resolution is adopted, at the Council’s discretion.

All conflicting or inconsistent Ordinances are repealed.

REPLACING SECTION 259-8, SPEED LIMITS**

BE IT ORDAINED by the Mayor and Council of the Borough of Franklin, County of Sussex, and State of New Jersey that the Franklin Borough Code is amended as follows:

**SECTION I.** Section 259-8 is hereby replaced as follows:

**§ 259-8. Speed limits.**

A. The speed limits for both directions of traffic along the streets or parts thereof described below and made a part of this chapter are hereby established at the rate of speed indicated.

B. Regulatory and warning signs shall be erected and maintained to affect the above-designated speed limits.

FOR ADDITIONAL PROFESSIONAL CONSULTING SERVICES**

**WHEREAS**, on August 13, 2021, the CFO/Administrator for the Borough of Franklin (“Borough”) resigned from her position; and

**WHEREAS**, a resolution was passed on August 27, 2021 to utilize Phoenix Consulting Group, LLC for the Temporary CFO/QPA until the new CFO starts with a not to exceed amount of \$10,000; and

**WHEREAS**, the Borough is interested in continuing the temporary CFO/QPA services an additional amount will be needed; and

**WHEREAS**, Phoenix Consulting Group, LLC submitted a proposal for professional consulting services to continue with contract negotiations at the rate of \$125 per hour; and

**WHEREAS**, it is estimated that the additional cost for such services will not exceed \$10,000; and

**WHEREAS**, the proposed cost is less than the bid threshold set forth in the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. (“LPCL”), and the contract consists of professional services that may be awarded without advertising and public bidding under the LPCL; and

**WHEREAS**, the Mayor and Council deem it to be in the best interests of the Borough to retain the services of Phoenix Consulting Group, LLC to complete contract negotiations as described above.
