#### BOROUGH OF FRANKLIN ORDINANCE # 07-2023

### AN ORDINANCE AMENDING CHAPTER 161 OF THE FRANKLIN BOROUGH CODE, ALLOWING FIRST FLOOR RESIDENTIAL ON SOME LOTS IN THE B-2 ZONE

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Franklin as follows:

**Section 1. Schedule A** to the Land Use Ordinance is amended to indicate that the phrase "upper floors only" for apartments in the B-2 Zone shall not apply to Block 602 Lot 25; Block 607 Lots 18, 19 and 20; and Block 608 Lot 12 which shall permit residential uses on all floors in the B-2 Zone.

The amended Schedule A attached to this Ordinance.

- **Section 3. Severability.** If any provision of this ordinance or the application of this ordinance to any person or circumstances is held invalid, the remainder of this ordinance shall not be affected and shall remain in full force and effect.
- **Section 3. Repealer.** All ordinances or parts of ordinances or resolutions inconsistent or in opposition to the provisions of this Ordinance are hereby repealed in their entirety.
- **Section 4. Effective Date.** This ordinance shall take effect after publication and passage according to law.
- **Section 5.** The Borough Clerk is hereby directed to give notice by certified mail at least ten days prior to the hearing on the adoption of this ordinance to the County Planning Board and to all others entitled thereto pursuant to the provisions of N.J.S.A. 40:55D-15. Upon adoption of this ordinance after public hearing thereon, the Borough Clerk is further directed to publish notice of the passage thereof and to file a copy of the ordinance as finally adopted with the Sussex County Planning Board as required by N.J.S.A. 40:55D-16.
